Public Comment: A member reported that he has had very good help getting from the transit to home and to all his appointments.

A member reported that we are having a hard time getting babies their tongue-tie fixed. Hopefully there will be a doctor that will be able to fix them in Union County soon. Also working on trying to get it covered by OHP since it is a procedure that is needed to get done. Sometime in the future it will be able to be covered.

Incentive Measure Update- Attached there is the incentive measures with Union county and EOCCO. This one is from November. We may not meet some of the measures. We will not meet the DHS one, we will be close to the Child Immunizations one. By meeting these measures is how we can get money back to fund our projects. Its good that we are in the green for ed utilizations. We were told we would meet our dental care measure. A lot of these will be shifting. Some of them won't be here next year, and we will be getting some new ones for next year.

Review of Public Meeting- They talked about what EOCCO 2.0 is going to be like. They talked about access for kids and seniors getting access to providers. There was a lot of discussion of the CHARM program. They were really moved on what we are doing in Union County. They would like to expand the CHARM program into other counties. Seeing how it helps prevent babies being born addicted to a substance.

2020 Grant Year Update- We decided two months ago that we would have a subcommittee to decide which community partners we were going to fund. We had to do a few different adjustments but all the projects that requested funds are going to be able to get funds. The projects that will be receiving funds are, The Warming Station which will be a

Cooling Station for the summer, The Lactation Support Group, CHARM, The Mentorship, Oral Care, Trauma Informed Coalition, Childhood Immunizations, and Double Up Food Buck's.

Community Benefit Report and LCAC Support Dollars- After a few months of confusion we finally got the Rides to Wellness contract figured out and then have received their funding. We still must wait till January 30th to see if the Warming Station will be able to open. We are going to reallocate part of the Warming Station CHW funds so it can be used for other things needed for the Warming Station.
