Call to Order and Introductions

Approval of May Minutes, Winnie Andrew moved, and Erin Bartsch seconded. Motion passed.

Public Comment: This time is for EOCCO members or their representatives to ask questions to, provide feedback for, or express concerns about the EOCCO, GOBHI, MODA, or any other related entities.

- An OHP member has a child who went to the walk-in clinic and the medication prescribed was not in the EOCCO database. The child is autistic and will not take typical medications, this made some of the prescriptions not feasible. The Pharmacy was like, we don't know what to tell you. The member called EOCCO and was able to

talk to someone in 5 min or less. Then EOCCO to her the prescription didn't exist. The member was asked to relay info back and forth between the two entities and eventually it was discovered the prescription needed to be formally requested to be entered in the data base by the pharmacy. As this point, we are four days without the medication, and they said it could be a few weeks. Not a lot of solutions were offered by any party and it was all sort of discouraging. The pediatric clinic followed up yesterday wanting us to use some more home remedies in the meantime.

- A member with a child in the LG district who is going into middle school, went to an IEP meeting with the school. She asked for his trauma to be included in his plan. She was told "we don't do that here", his diagnosis is about his stutter and the trauma aspect can't be a reason he has an IEP. He received services through CHD and has other diagnosis from his doctor. The member is concerned that the GOBHI/School District partnership is not as solid as it could be!
- A member with transportation issues of the past has had all the concerns resolved!!

Incentive Measure Update: These monthly reported out measures are determined by area of concern and is one tool to look at our community's health. These measures determine how much reinvestment money we receive each year and what we need to work. Wherever the member chooses to receive care is where they are measured. For example, our Union County Numbers are not affected if a North Powder Kid do sees a doctor in Baker. Two new incentive measures have been added: Morphine Equivalence Dose and Established PCP Care.

Dental Follow up: Tele dentistry Pilot is in Gilliam and Sherman counties in the EOCCCO. Amanda will hear more about it at the RCAC and will bring more information back. Kaylen Todd has created a proposal and will reaching out to Grande Ronde Hospital to see if they are interested. Amanda would like to work on a Baker proposal as well.

Community Health Plan, draft review and approval: The committee has been meeting for five or so months. The attached CHP is closely related with the GRH CHP and will be considered when the Public Health Department competes their own. The proposal is due at the end of June. Rochelle Hamilton moved, and Sherlyn Roberts seconded, and the motion passed.

LCAC Coordinator Search: The subcommittee search has commenced. Interviews will begin next week for our four applicants.

Community Benefit Report and LCAC Support Dollars-

- DUFB: is trucking along and has received their check
- CHARM: is busy! They have helped moms with rent, supplies, getting an ID, preventing electricity shut off, transportation, and more.
- Warming Station: has been discussing a year-round shelter in a permanent location. They still do not have a location for this year.
- Partnership Meetings: are waiting for Jill to return, the first one will be in August.
- Mentorship Project: they have found the coordinator and will be starting the project in the fall.

Innovation Café Report: Chris Evans, Erin Bartsch and Cami Miller attended. The attended workshops on supportive housing, trauma informed work, food insecurity, and more. It was amazingly educational and went well.
