Approval of September and October Minutes: Winnie Andrews mad a motion to approve both September and October and Lisa Ladendorff seconded. Motion passed

Public Comment:

- A member announced that we are in the process to revising the membership application and if not let us know you would like to just be a community partner. If not heard from we will be taking you off the roster.
- One member mentioned they have a friend who was navigating services for behavioral health disabilities and this morning she was able to sign him up for services. It took about 2 months and it seemed like many people didn't know how to help her. Found out there were changes to this process, so people were unsure of how the new process was working

Behavioral Health Funding Cuts: This is not finalized but they are hearing that this coming fiscal year EOCCO will be receiving big funding cuts. We need to be talking EOCCO about how needed these services are to our community. Nothing is set in stone yet but there are conversations happening. Even if there are funding cuts, we will be looking for other funding streams. There have been funding increases in other services. The CAT services program will allow to provide children intensive services for at risk children in their own home. This services 4 hours in home services each week which is the option from inpatient services. IIBHT can be provided anywhere in the community for children. Hopefully next month there will be full detail online If anyone sees any gaps or problems in any services please feel free to contact Aaron Grigg.

2020 Updates: We have just submitted our 2020 2nd progress report. At our last meeting we discussed reallocating \$10,000 from the mentorship and

reallocating it to other programs. We received 8 applications and the subcommittee provided their suggestions. We had to provide a reallocation re justification and progress report and hopefully we will hear back before thanksgiving to know if those projects will be awarded these funds or not. If we can't reallocate them then they will be become rollover funds for next year.

2021 Updates: The 2021 applications have been sent out and if you or anyone you know would like to apply to please submit the applications before December 1st. We will go over them in the subcommittee between the 1st of December and the LCAC meeting in December. There are 3 different ways applications should be striving for -CHIP Social determinates of health or COVID relief.
