Lake County CHIP/LCAC Minutes

Date and time: February 11, 2021 – 3:00 p.m. **Place**: Virtual Meeting (Zoom)

EOCCO update: Tracey Blood informed the council about the March RCAC (Regional Community Advisory Committee) meeting. The focus of this meeting will be towards membership engagement. Audrey Egan gave an update on the new webpage launched by EOCCO (Eastern Oregon Coordinated Care Organization) on their website. So far it includes a provider page and a member page regarding COVID vaccine questions. Audrey Egan then posted the link to the webpage.

Ombuds Program PPT: Collin Sanders and Rochelle Capone from the OHA (Oregon Health Authority) presented about the Ombuds program through the Community Partner and Outreach Program.

VISTA Project update: Katie Mannina shared results about the OHP (Oregon Health Plan) members survey results. As of now, the participants shared concerns about mental health and food access.

Clara Morris shared updates about her project with AmeriCorps. The project involves recommendations to the EMS service providers and Lake County in general to identify what the OHP members have experienced throughout the pandemic. This will provide helpful recommendations to improve future disaster response.

CHIP Updates: Arvinder Singh gave information about the vaccine clinics at the Lake County Fairgrounds. The clinics are scheduled for Friday (2/12) and Saturday (2/13) from 3 p.m. -6 p.m. Then, Arvinder Singh spoke about the Sources of Strength program which goes live at the North Lake School next week.

Grant Updates: Piper Marks shared that the LCAC grant has been submitted and in early March we will find out if we got that.
