<p>Welcome and Introduction Minutes: of June 2021 Motion made by RaeAnn, 2nd by Gayle. Minutes approved.</p>	
Discussion	<p>EOCCO Updates- Tracey Blood</p> <ol style="list-style-type: none"> 1. SHARE Initiative purpose: 310K funding for applications in EOCCO region. Projects focused on housing. Up to four grants to be awarded in the 12 county EOCCO region. 110K per application. LCAC's are to provide first level screening of applications. LCAC subcommittee to review applications then send on to EOCCO for review. The applications are due to the LCAC on Aug. 9, which then submits it's recommendations Aug. 27, by 5pm to EOCCO. Subcommittee makes the recommendation not LCAC. 2. Reports submitted by the LCAC in June: CHP update. Demographic profile report. Baker County responses. 3. Kali: Incentive Measure updates: Most recent county data. Shared screen. Year to date performance based on claims data through May 31 2021. Red indicates areas not met. Green are met.
Discussion	<p>Dental Discussion: Nancy Avery, OHP ODS Dental Manager: In Baker county for dental access, have contract with Eastern Oregon Dental Group, for capitation. Have worked to secure specialty services: Meridian Idaho for pediatric and other. 'Need to meet' numbers are going down, so that is good. Specialty Services in Meridian: Dr. John Fluid (sp). Well Point Dental. Total membership in Baker County 5348. 4900 are assigned to Eastern Oregon Dental Group. Challenge to get providers and access. Amy: What are your access concerns? Tracey: Barriers: Taking months to be seen. Even when experiencing oral pain. Impacts other parts of their lives: mental, physical health. Dental seems to be lower priority to get in for appointment for EOCCO members rather than private insurance. 3 month wait, vs. next day wait (private). Coverage of services: Adult members: crowns, root canals not covered. Option is a tooth extraction instead. Chris Evans: 40% of baker residents have had no dental visit within the last year. Some access barriers relate to transportation, children that need to go to pediatric dentist, child can get transported to another county but not family. Or, parent has appointment, and can't take child with them because not allowed on bus, etc. Highest need for all ages, barrier is insufficient access. Many weeks out to get seen for broken tooth. Urgent medical needs. Valley Family Health can see folks, can come to our area. Just need the invitation. Kelli: St. Al's needs in ED: Data: Our ED visits for dental visits are decreasing. Present to ED when in pain. Data has improved. Not seeing recurring visits. Nancy: asked about CCNO LCAC grant. Can a different provider provide the services? ODS can provide reimbursement options for out of county, etc.</p>

	<p>Oral screenings during well child visits? Debra Bell asked. Contact Raven Davis at St. Luke's to get answer.</p> <p>Nancy: Weren't quite sure what the concerns were coming into this meeting. I wonder if it would be helpful, if put together proposed solutions/responses, and brought to next meeting. Happy to do that. Address these concerns that have surfaced today. Traveling dentistry, traveling specialists, reimbursements, logistics in finding office space, list of strategies we would like to put in place as we work on these challenges.</p> <p>Amy Lawrence: Q about transportation issues: Is this due to COVID or always this way? Answer: Issues have been pre-covid as well. Driving implications about passengers. Not making any movement? And, what is timeframe to get into an appointment. Want specific examples. Three months out for getting tooth fixed. Then 4.5 months out. Total of 7.5 months to get root canal. (Kristina). Crown not covered. Tooth has shattered. Have to come up with money for a crown. Do not have \$200 for a crown. I can't chew.</p> <p>Haley: We would like to know what is covered and why. Lowdown on what is covered and not covered. Need to clarify the services and the needs.</p> <p>Additional need for conversations with Nancy and her team.</p> <p>Tracey: Hope we can continue this conversation in September, hopefully in person, and have Dr. Peters/Curtis to attend, who is on EOCCO board and is a provider at Eastern Oregon Dental.</p> <p>Chris Evans: The mobile clinic is going to Huntington. Is available to come to Baker. September 7th is next meeting. Dental conversation will continue.</p>
