Approval of February Minutes: Winnie Andrews makes a motion, Matt Scarfo seconds, no further discussion, motion passes

Public Comment:

Jenn – it's been discussed during RCAC meetings how much members are expected to share. She wanted to recognize how much it's appreciated when individuals do speak up about their issues or concerns during this time, knowing it's not always the most comfortable setting to share in. It's something they hold very dear to have folks share and that's it's an important process and greatly valued.

Shannon asks if eligibility for OHP is based on income, is there a reason why people wouldn't qualify for transportation services? She's been experiencing a need for medical transportation and individuals on OHP not qualifying.

Troy plans to look into this and follow up with Shannon.

EOCCO Incentive Measure Progress Report (Kali Paine): Kali presented a review of the first of several EOCCO Incentive Measure Progress Reports for Union County. This is a follow up of information shared last month as she plans to share the progress more on a monthly basis. Kali discussed the measures that have and haven't been met, and there's no concerns since it's only been half of the year. Measures need to be met by 12/31/2021 on a calendar year. In the progress report she added a comparison from last year at this same point.

Kali shared information on the Well-Child Visit incentive program which will gift a \$20 Amazon gift card if children between the age of 3-13 visits their doctor before December 31st, 2021. Instructions are listed in the attached flyers above provided in English and Spanish. Stephanie followed the meeting by sharing the flyer for more information to the LCAC email list.

Discussion: The option was offered to skip next month's meeting in August as a break to accommodate busy summer schedules.

Shannon makes a motion to skip the August LCAC meeting to resume in September. Kathy seconds the motion. No further discussion.

There will be no Union County LCAC meeting officially held in August.

Discussion: Resume in person meetings in September.

Troy shares that other LCACs are having in person meetings starting in September with a hybrid in person and virtual option.

Liberty shares she thinks September would be good but if numbers spike in August, then she hopes we can re-evaluate if that happens.

CBIR Updates: Liberty shared they received the first payment for CBIR payments last month and are working on getting the first wave of funding out.

Growing Community Roots - Jenn shared this program is for school aged children and that the project is up in running and seems to be off to a successful start. School is still happening and is continuing to move forward and is going great.

CHARM – Shannon shared the program is doing well and is going back into family homes which has been tough with prior COVID restrictions. They have had 16 participants in a fiscal year, which is very successful and they're still going strong.

Shannon is looking for information to connect a similar program to their Local CAC in NE Portland – Troy will help provide the Portland connection.

Senior Oral Dentist Program – Kathy served 7 consumers but not one was OHP consumer. They do have funds leftover but it's a matter of getting people into the dentist. For the next funding round, they have 12 on the waiting list for Medicare and 2 on the OHP. Please spread the word for senior OHP members to access this program!

Update: RCAC new name - Regional Community Health Partnership. The name was changed to continue its function without having to meet all the requirements that CAC typically must by not calling it a CAC. The structure of membership will not change but with this change they're hoping to report to the EOCCO board more directly.
