Approval of February Minutes: Winnie Andrews makes a motion, Wendy Roberts seconds, no further discussion, motion passes

Public Comment: Winnie comments that she appreciates the public transportation is up and running smoothy for medical appointments.

Troy shared that Jen Goodman is now the RCAC chair and to please share any information from a community level that she can present during those meetings.

The RCAC name will be changing to help improve recruitment of consumers to advocate on their needs. What's needed during these meetings is to have more advocates for consumers rather than sharing individual issues or problems.

Community Health Plan Review CHP (Troy Soenen)

Troy reminded the group that the data will remine the same from 2019 as there's not much difference in what has been collected as this point, but what they're looking for is an approval of priority. The discussion was opened to see if anyone would like to change the priorities on the current CHP.

Stephanie sent out the CHP survey which needs to be completed by next Tuesday.

Wendy said she doesn't think we need to make any changes – the hospital survey discussed with CHD and EOCCO that they are all working towards the shared goals of SDoH and behavioral health. She's excited to see what will be coming out of their recent assessment and the survey will be going out in September. Please be sure to fill the survey out once it's received and them know how they can better survey the community.

EOCCO Incentive Measure Progress Report (Kali Paine): Kali presented a review of the first of several EOCCO Incentive Measure Progress Reports for Union County. Data compiled for 2021 is based on rates from January 2021. The LCAC agreed to review these progress reports on a quarterly basis with Kali and discuss opportunities for improvement.

Kali discussed the measures that have and haven't been met, and there's no concerns since it's only been half of the year. Measures need to be met by 12/31/2021 on a calendar year.

Jen would like to see a comparison of former years to help project if we will meet these metrics.

Rob would like to hear about this monthly to make more data informed decisions.

CBIR Updates: Liberty shared they received the first payment for CBIR payments this week and hope to get the first wave of funding out early next week.

Growing Community Roots - Jen funded something called growing community roots for school aged children and that project is up in running and seems to be off to a successful start.

CHARM – Shannon has been updating binders and information for participants. She also wants to focus on getting their program name out there to build the program and community presence. They currently have 5 participants and it's still going strong! CHARM has paid move in fees, rent, back rent, car tires, utilities, breast pumps, etc.

Early Head Start would like to partner with CHARM during this revamp.

Double Up Food Bucks – the Program is funded from the state for 20 for 20 and has been used quite a bit so far.

Announcements:

Eastern Oregon Community Resource Network EOCRN (Chris Evans) – This program is used to fill gaps on behalf of community members that we're all serving.

EOCRN would like some feedback and suggestions for improvement from the group. They currently have an 80% success rate in filling requests, so it appears that it's been working.

Chris asked how the group thinks it's working and what could they do to improve its usefulness? The group provided overall positive feedback about the network/website.

EOCRNs next step is to broaden the net, do some marketing and share at different community forums, rotaries, city business planning folks, and get the word out as much as possible. Anyone can share this within their networks so please spread the word!

• **CCNO Rental Assistance:** CCNO has a significant amount of rental assistance available – please put the word out.
