## Lake County CHIP/LCAC Minutes

**Date and time:** March 11, 2021 – 3:00 p.m.

Susan Pointere called the meeting to order at 3:04 p.m. and asked all members to introduce themselves.

No previous month minutes were available for review and approval.

**Public Comment:** None.

**EOCCO update:** Tracey Blood reminded the members about the RCAC (Regional Community Advisory Committee) meeting next week from 9 p.m. to noon. Next, Tracey Blood shared how the EOCCO is working on updating county CHP's (Community Health Plan), deadline is June 2021.

Audrey Egan presented information about Lake County incentive measures.

**South Lake Cost & Utilization:** Paul McGinnis presented information about the Cost and Utilization report.

**Frontier Veggie RX:** Marci McMurphy shared information about her work with other counties regarding the Veggie RX program and how Lake County will be part of it in 2021. The two funding sources to bring Veggie RX to Lake County are Nutrition Oregon Campaign and LCAC CBIR funds. Marci McMurphy is working right now on finding vendors in the area and getting in touch with prescribers.

**VISTA Project Update:** Katie Mannina spoke about her work on the Community Health surveys. Next, she informed the members that Clara Morris, Arvinder Singh and herself will be presenting at the RCAC meeting next week.

Clara Morris spoke about the LCAC working group meetings. These meetings are bi-weekly.

**EOCCO Member Comment:** None

**CHIP Updates/ Grant Updates:** Arvinder Singh shared about the Easter food distribution event which will be on April 1<sup>st</sup>. The food distribution event is hosted by the Lake County Foodshare. Next, Arvinder shared about the job openings for the Summer Food Service program. Arvinder Singh shared then the numbers of vaccinated people in the Lake County.

For grant updates, Arvinder Singh spoke about EOCCO board not allowing Eastern Oregon counties to use continuing projects Opt-in funds to support the 2020 LCAC projects. The EOCCO is however allowing us to revise our LCAC 2021 proposal to include rollover funds from LCAC 2020 grant. We have \$10,400 in rollover funds. We had asked EOCCO for \$20,000 for the continuing projects fund. Kristi Albertson is working on revising the LCAC budget.

There was a discussion about this among the members.
