Reports & Updates

Frontier Veggie Rx

- Our application for CBRI funds for the upcoming year has been approved, although not yet officially announced.
- The new year for the program begins on April 1st.
 - Sharon will share contact information with Marci of some folks who could provide locally grown produce in case vendors are looking for that. Some of these producers may also like to become vendors.

- J&J mini mart in Rufus is signed and trained as a new FVRx vendor.
- Participants who were involved in the program last year will need to renew their eligibility if they wish to continue this year.
- This year, participants will be asked to take a pre and post- program survey. This will help collect data about the effectiveness of the program to improve health outcomes.
- Marci is hoping to find 10 households who would like to participate in an online nutrition education component. There could be an opportunity for participants to receive one-on-one counseling with Cindy Brown of OHSU extension, using the Cooking Matter or Food Hero curriculum.
- Transportation to FVRx vendors is still a barrier for some participants. Carrie Silcox at the Sherman County Senior Center would have information on when seniors might like to take the shuttle to access vendors. Kathy Fitzpatrick will discuss with Marnene at Sherman County Transportation to coordinate shuttles.

Sherman County Medical Clinic Update

- New provider will start Monday, March 8th.
- As of 2/28, 234 first doses and 123 second doses of COVID vaccine have been administered by the clinic.

Advantage Dental Update

- Dental services are a metric for kids in DHS custody.
- Since tele-dentistry has been expanded, Ashley can now do phone call visits with families that meet the requirements for this metric.
- This practice will continue to be in place even after COVID19 restrictions and protocols are lifted.
- These oral health assessments (as well as behavioral and physical health assessments) are required for all youth in foster care from 1 – 17 years old.

MCCFL Update

- Wasco Events Center is up and running as the new location for MCCFL. Jennifer Harwood is the only clinician right now while Megan Stone is on maternity leave.
 - o Jennifer can see children, adults and families and welcomes referrals!
- Jennifer has advertised the new location with flyers throughout Sherman County but would love folks to help spread the word.

Columbia Gorge Food Bank Update

- Sherman Co. food bank is open once/month
- Rufus location is open twice/month
- Farm-Family program continues.1,000 boxes per week are being distributed throughout our 3 county region.
- Boxes have produce, dairy and meat.

Update from Kathy Fitzpatrick

- 2 vaccine clinics were held at Celilo Village and were well received.
- One Community Health (OCH), The Next Door Inc (TNDI), and Columbia River Intertribal Fish Commission (CRITFC) were all partners in coordination.
- OCH & CRITFC will have mobile vaccine vans on the road in both OR and WA soon with a goal of reaching native populations along the river.

GOBHI Update

 Chelsea Maranville is currently coaching parents in a triple P parenting class, which is still open to participants who live in Sherman County. Referrals welcome!
