Jesse shared two updates on the behalf of Lindsay Grosvenor Fruits & Veggie RX Program Reports last week 67 households enrolled in the voucher program 138 Adults 75 OHP Members 26 children's 21 OHP members 14 67 households were enrolled by community health workers 19 were referred to chws to help with resources.
