EOCCO Metrics - Kali Paine, Moda	Marci McMurphy 11:35 AM Now: EOCCO Incentive Measure presentation by Kali Paine, EOCCO/Moda	
	Kali presented on the 2022 - 2023 Incentive Metrics sharing a slide deck. Data is lagged for claims based measures because insurance claims take a long time to process. Currently, we only have one month of data for 2024. Initiation and Engagement of Substance Use Disorder Treatment (IET). This is one of the measures we don't think we will meet in 2023, so we are focusing on it more this year.	
	Patty: As we know, substance use is one of those disorders that people have, and have again and again. Can it be for folks who are diagnosed and re-diagnosed? Kali: The way the measure is configured the term "new diagnosed" (first time diagnosed) or first within the last six months. If they haven't had one in the last six months, they would again qualify.	
	Sarah Poe 11:43 AM If anyone has trouble accessing care in their area, we've had good experiences with Boulder Care, which is also being funded by OHA. Virtual addiction care, including MAT. <u>https://www.boulder.care/</u>	
	Kali: OHA configures the measures and the CCOs don't have much say in this. Kali continued with the slide deck.	
	Patty: The third bullet, does it have to be all of them or could it be any one of them?	
	Kali: It could be any one.	
	Patty: I'm sure you have heard that the legislation has

At this moment, Kali Paine is reviewing the Incentive Measures, specifically focusing on the Initiation and Engagement in SUD Treatment. SUD= Substance Use Disorder Maurice: Could we get some kind of format or timeline - say they went to a place in Washington, it can go from 30 to 90 to 120 days? It is all over the map. When we send someone to a facility in Washington, we don't want them to panic that they have to pay. All they need is the CCO Medicaid to get covered in WA or any other state. Can we get documentation that the treatment episode is covered as long as you are coming back to Oregon? It creates a barrier when someone is willing to go, but the insurance piece needs to be covered. They need to know they are covered, as long as they come back. Kali: You are saying what types of services are covered for Oregon Medicaid members, including out-of-state treatment? Maurice: They need the EOCCO card, say if they go to the emergency room. If they go to a different state for longer than 60 days, it will switch. This information would be helpful for both the tribe members and other CCO members.

	Kali: I think that would be very helpful for folks to have something simple, rather than have it in insurance speak on how it works.	
	Summer: The key driver is where you leave. You can go out of state, after 60 days it is up to the CCO. I don't think we have ever released anyone. If they are going out of state for treatment, but are coming back to Oregon, it comes to us for review. If they are getting treatment and coming back we would keep them as a member. We can get this information ready for communication. For more information EOCCO is presenting a learning collaborative. (see link below)

	The Community Resource Network (CRN) is a free web-based tool that connects resources to unmet needs through sharing information between organizations and community members. It is a community engagement platform that focuses on firming up safety nets. They align services, connect resources by using private sector innovation, public sector resources and mobilizing social service networks. Amy went through the slide deck showing how a request would work in the system.	
	Amy: First CRN was in Marion County. The next one was the Eastern Oregon Community Resource Network (EOCRN) serving Union, Baker, and Wallow Counties. In	

the fall of 2023, the Umatilla Morrow Community Resource Network (UMCRN) was established, serving Umatilla and Morrow County. Sarah Poe 12:04 PM Is there a CRN available to all counties? The EOCRN somehow doesn't include the biggest Eastern Oregon county- Malheur!	
Sarah Hartenstein 12:05 PM I'm wondering who services Wheeler County as well? I didn't see it mentioned in the previous organizations.	
Amy: We don't have a statewide CRN. Wallowa, Baker and Union had an "underground list" to get services. They went out bcc to everyone. We were able to bring the CRN to them to make things more efficient. We aren't opposed to bringing a CRN to other communities. The counties we serve now were the most interested. We haven't expanded to Wheeler, Sherman or Wasco. Again, we aren't opposed to expanding, but we haven't had the interest nor have we been approached by the communities to bring this idea to them.	
Sarah Poe 12:05 PM Few more questions: Is this closed-loop? Is this an alternative to Connect Oregon? Our health department has been building an agency finder because 211 doesn't work well here. Too many of us are recreating the wheel.	
Sarah: We also have Unite Us, and Connect Oregon. We've put a lot of time into an agency list. 211 doesn't work well for us.	
Amy: We see the CRN as a complementary service to the others. The challenge with Connect Oregon is they don't engage with the entire community. They work with medical providers and behavioral health providers. Most of our requests are for tangible items - a bed, walker, or t-ball equipment, for example. These won't work for Connect Oregon and 211info.org. We work with all sectors of the community, faith-based, private companies, community non-profits and individual donors. These entities would have an individual profile where they say what they are interested in contributing to. The client doesn't have to be enrolled in a specific program. The CRN meets traditional and non-traditional needs. It is geographic centric - so you can choose which area you want to assist. Everything is anonymous.

Older Adult Behavioral Health Initiative (OABHI) - Roni Hyde, Rod Harwood, Kai Nichols with GOBHI	Roni Hyde, GOBHI Marci McMurphy 12:28 PM Now: Older Adult Behavioral Health Initiative (OABHI) presentation by Roni Hyde, Rod Harwood, and Kai Nichols	
	Roni presented the slide deck and gave a brief overview about the Older Adult Behavioral Health Initiative (OABHI) at GOBHI.	
	OABHI is a state-wide program that launched in 2015 to better meet the needs of older adults and people with physical disabilities.	
	Rod spoke about how many people are 65 and older now. It has grown from just under 13% of Oregon's population to over 18% in 2019. The numbers in Eastern Oregon are even higher. In Wheeler County, 35.3% are 65 or older and ranks as #1 in the state. Gilliam County has the 3rd highest at 31.2%, Grant County is #4 with 31%, Wallowa County is number 5, Baker County #7, Harney County is #12, Lake County #13, Sherman County #15, Union County #19, Malheur County #29, Umatilla County #32, and Morrow County is #34 in the state of people with a population 65 years of age or older. Rod: If you have a case you'd like help with, please go to

Each person on the OABHI team works with different counties. Roni works with Wasco, Sherman, Gilliam and Wheeler Counties. Rod works with Morrow, Umatilla, Union, Wallowa, and Baker Counties. Kai works with Grant, Lake, Harney and Malheur Counties.

Partnerships and Collaborations - Rod covered a few of the people they collaborate and work with. Aging and people with disabilities (APD), Area Agencies on Aging (AAA), Community Mental Health Programs (CMHPs), Faith communities, physical and behavioral healthcare providers and clinics, senior meal sites, and senior community centers, and Tribal services.

Patty: Harney county has an aging population as well and they live far away from each other. The American Legion does buddy checks on our older adults. As people get older, processing things can become more difficult. For example, if you get a phone where the menu is complicated. I like to see these collaborations!

Roni: Thank you for adding that! We'll be in touch with you.

Kai introduced herself and highlighted the OABHI workforce trainings.

Kai: We can create *a la carte* trainings to meet communities' needs. She reviewed the current <u>trainings</u> OABHI is offering. Understanding Anxiety in Older Adults, Dementia and Serious Mental Illness. Lewy Body Syndrome, Depression in Older adults, Alcohol Use in Older Adults, and Behavioral Activation.

Health-Relate d Social Needs (HRSN) - Mina Zarnegin with Moda	Marci McMurphy 12:48 PM Now: Health-Related Social Needs (HRSN) presentation by Mina Zarnegin Mina oversees the HRSN for EOCCO, and has been with Moda for almost 6 years.	
	Mina presented a slide deck explaining who will be covered. This includes members who enrolled in Medicare (in addition to OHP) for the first time, not more than 9 months ago, members who may be homeless soon or spend at least 50% of their income on rent or don't have a regular place to sleep and/or are staying at someone else's home, members who have received care in the Oregon State Hospital or a large substance use disorder residential treatment program in the last 12 months, members who have been released from a jail or detention center, the Oregon Youth Authority facility, or prison in the last 12 months, and members who have been involved with Child Welfare Services in Oregon at some point, or been in foster care, or received adoption, guardianship, or family preservation services, or been in court for child welfare.	
	Some of the support services involve climate devices, such as, air conditioners, mini fridges, and space heaters. One slide covered all the many reasons that someone would need and be eligible to get the devices. This included if a member was younger than 6 or 65 or older, pregnant, having a physical or developmental disability, taking medication that needs to be refrigerated, having diabetes, chronic heart problems, chronic lung problems, asthma, using oxygen at home, and many more. If a member has a health condition that isn't on the list on the slide, they may
