Demographics

Population- 2017 ACS

- EOCCO 203,250
- This represents a net gain of 6,265 people since 2013
- All counties gained population with the exception of Grant County, with a loss of 35 people in that same time period
- Over $\frac{1}{2}$ of the overall growth occurred in Umatilla with a gain of 3,380



Demographics

The % of the population 65 and older in the EOCCO Region is 19.5% compared to Oregon overall at 17.2%

Individual counties experience a higher % of their own population age 65 and older

Baker 26.7%, Gilliam 28.2%, Grant 32.2%, Harney 24.2% Lake 25.1%, Malheur 17.7%, Morrow 16.2%, Sherman 25.9% Umatilla 15.1%, Union 20.8%, Wallowa 29.5%, Wheeler 32.6%



Demographics

The % of the population age 0-17 in the EOCCO Region is 22.9% Compared to Oregon overall at 21%

However from 2013 to 2017 the following counties lost population in that cohort. Baker, Gilliam, Grant, Harney, Lake, Malheur, Morrow, Sherman, Wheeler

Only Umatilla, Union and Wallowa gained



Demographics

The % of the population identified as Hispanic in the EOCCO Region is 19.0% compared to Oregon overall at 12.4%

Malheur 32.9%, Morrow 34.7%, Umatilla 25.6%



Social Determinants of Health: Housing

2017: Renters paying more than 35% of their income on rent in Oregon overall is at 44%

Baker 32.6%, Gilliam 23.8%, Grant 28.8%, Harney 35.2% Lake 38.9%, **Malheur 51.8%**, Morrow 27.3%, **Sherman 44.5%** Umatilla 31.7%, Union 40.6%, **Wallowa 45.4%**, Wheeler 20.4%

Three factors: wages, quality of housing, and availability of housing



Social Determinants of Health: Housing

Percentage of houses lacking complete kitchen facilities - 2017 ACS, self identified.

- Oregon overall is 1.3%
- 5 EOCCO Counties are higher than Oregon overall

Social Determinants of Health: Housing

2017: Households with No Telephone - Oregon overall 2.7%

Seven of twelve are higher than Oregon overall

2017: Households without access to Personal Transportation - Oregon overall 7.9%

• Only Malheur is higher than Oregon- urban dwellers have better access to mass transit systems

Social Determinants of Health: Unemployment/No Health Insurance

Unemployment in Oregon overall: 4.9%

• Sherman and Wheeler are lower

2017: Oregon uninsured was 6.2%

• All EOCCO Counties were higher with a range of 6.9 to 8.3%



Social Determinants of Health: Education

5 Year Graduation Rate in Oregon 77.8 per 100 students

Generally graduation rates are trending downward

Only Gilliam, Wallowa and Wheeler are lower than Oregon overall

Social Determinants of Health: ALICE

Asset Limited, Income Constrained, Employed (ALICE) Percentage of households that are one unexpected expense away from financial crisis - Oregon is 41%

Each EOCCO County % is higher than Oregon overall

Baker 46%, Gilliam 48%, Grant 49%, Harney 52% Lake 55%, Malheur 55%, Morrow 41%, Sherman 62% Umatilla 45%, Union 44%, Wallowa 43%, Wheeler 48%



Social Determinants of Health: Food Insecurity

There are 26,180 people in EOCCO who are Food Insecure. That is 12.8% of the population. Oregon overall is 14.2%

%s for Baker, Grant, Harney, Lake, Sherman, Union, Wallowa and Wheeler were higher than Oregon



Vulnerable Population- Childhood Poverty

- Children age 0-17 living in poverty Oregon overall 17.2%
- There are 10,410 people living in poverty in the EOCCO, 22.3%
- EOCCO Counties all have higher poverty rates than Oregon overall
 - Range 18.2 (Sherman) to 39.9 (Wheeler)



Early Childhood - Abuse/Neglect

Rate per 1,000 children experiencing abuse or neglect- Oregon 12.8

Only 3 EOCCO counties are lower than Oregon

Baker 33.2, Gilliam 13.7, Grant 21.9, Harney 45.7 Lake 37.2, Malheur 30.6, **Morrow 12, Sherman 6.2 Umatilla 5.5**, Union 15.9, Wallowa 27.7, Wheeler S

Early Childhood - Foster Care



Early Childhood - 3rd Grade Reading

2017: Percentage of 3rd graders meeting State Reading Level Standards in Oregon overall was 47.4%

Generally Trending Down (Test standards were charged over 2013-2017)

Baker 48.2%, Gilliam 36.3%, Grant 46.7%, Harney 52.5% Lake 48.2%, Malheur 39.4%, Morrow 40.9%, Sherman 62.5% Umatilla 32.9%, Union 39.1%, Wallowa 40%, Wheeler 69.4%



Early Childhood - Immunizations

Children reaching age 3 with all required immunizations - Oregon overall 68%

Incentive Measure

Only 3 EOCCO counties Malheur, Morrow and Sherman were better than Oregon



Early Childhood - Childcare

"Oregon Childcare Deserts"

Childcare Desert defined as county with more than three young children for every regulated child care slot.

Regulated child care slots are Certified Centers, Certified Family and Registered Family Providers

Only Wheeler and Sherman are NOT childcare deserts

Vulnerable Population - Maternity

"Inadequate Prenatal Care"

Percentage of Mothers not receiving care in the first trimester or completing all their visits. Oregon overall is 6.1%

Baker 9.7%, Gilliam S, Grant 9.5%, Harney 2.9% Lake 8.1%, Malheur 12.3%, Morrow 11.3%, Sherman 0% Umatilla 6%, Union 9.9%, Wallowa 3.2%, Wheeler S



Vulnerable Population - Maternity

"Low Birthweight"

Rate per 1,000 live births who weighed 5.5 lbs or less. Oregon overall 68.3

Baker 83.3, Gilliam S, Grant 95.2, Harney 69.4 Lake 161.4, Malheur 99.8, Morrow 29.4, Sherman 66.7 Umatilla 53.8, Union 111.1, Wallowa 31.4, Wheeler S



Vulnerable Population - Maternity

In 2017 according to the CDC's Pregnancy Risk and Monitoring System (PRAMS), 47.6 % of all Mothers in the EOCCO service area suffered from depression during or after their pregnancy.

This is large increase from 2016 when it was 21.3%



8th and 11th Grade Mental Health

There is a downward trend over the years in 8th and 11th graders reporting Excellent, Very Good or Good general mental health

More 8th graders than 11th graders reported worse mental health

Suicidal Ideation among EOCCO 8th graders was 18.6%

Oregon overall is 16.9%



Health Behaviors - Smokeless Tobacco

2010-13 BRFSS ADULTS in Oregon 7.7%

Where there is data, all EOCCO Counties are higher than Oregon

Baker 19.9%, Gilliam S, Grant S, Harney S Lake 13.2%, Malheur 15.3%, Morrow 17.9%, Sherman S Umatilla 11.1%, Union 23.2%, Wallowa 11.7%, Wheeler S

Baker 29%, Gilliam 33%, **Grant 23.8%**, Harney 38.7% Lake 34.1%, Malheur 31%, Morrow 29.5%, Sherman 33.6% Umatilla 33.2%, Union 27.7%, **Wallowa 22.2%**, Wheeler 37.7%
