Priority Issue:

Wellness Promotion and Prevention

- Promote equitable access to community education regarding comprehensive health care (behavioral, physical, and oral health) across the lifespan.
- Increase community awareness of preventive healthcare and the impacts of Social Determinants of Health and trauma on health to reduce stigma and promote utilization of comprehensive healthcare.
- Promote understanding and improvement of Social Determinants of Health to improve health equity for vulnerable populations in the community.
- Improve the accessibility and efficacy of healthcare provided in our community through promotion of trauma-informed practices.

Problem to be solved:

Reduce the negative impacts of Social Determinants of Health in our communities.
