I. Length of Authorization

Coverage will be provided for six months and may be renewed.

II. Dosing Limits

A. Quantity Limit (max daily dose) [NDC Unit]:

- Rybrevant 350 mg/7 mL solution as a single-dose vial: 4 vials per 7 days initially for 4 weeks, then 4 vials every 14 days thereafter

B. Max Units (per dose and over time) [HCPCS Unit]:

- 700 billable units (1400 mg) every 7 days for 4 weeks followed by 700 billable units (1400 mg) every 14 days thereafter

III. Initial Approval Criteria ¹

Coverage is provided in the following conditions:

- Patient is at least 18 years of age; **AND**
- Patient has been instructed/counseled on limiting sun exposure and the use of protective clothing and/or broad-spectrum UVA/UVB sunscreen; **AND**

Universal Criteria 1

- Patient does not have untreated brain metastases (clinically stable asymptomatic brain metastases are allowed); **AND**

Non-Small Cell Lung Cancer (NSCLC) 1-4,1e † ‡

- Patient has epidermal growth factor receptor (EGFR) exon 20 insertion mutation positive disease as detected by an FDA-approved or CLIA compliant test ❖; **AND**
- Patient has recurrent, advanced, or metastatic disease (excluding locoregional recurrence or symptomatic local disease without evidence of disseminated disease) or mediastinal lymph node recurrence with prior radiation therapy; **AND**

- Used as subsequent therapy as a single agent in patients who have not received prior amivantamab-vmjw therapy; **AND**
- Patient has disease progression on or after platinum-based chemotherapy

Preferred therapies and recommendations are determined by review of clinical evidence. NCCN category of recommendation is taken into account as a component of this review. Regimens deemed equally efficacious (i.e., those having the same NCCN categorization) are considered to be therapeutically equivalent.

IV. Renewal Criteria ¹

Coverage can be renewed based upon the following criteria:

- Patient continues to meet the universal and other indication-specific relevant criteria identified in section III; **AND**
- Disease response with treatment as defined by stabilization of disease or decrease in size of tumor or tumor spread; **AND**
- Absence of unacceptable toxicity from the drug. Examples of unacceptable toxicity include: severe infusion-related reactions, interstitial lung disease, pneumonitis, dermatologic adverse reactions (e.g., acneiform dermatitis and toxic epidermal necrolysis), ocular toxicity, etc.

V. Dosage/Administration ¹

NSCLC	<ul style="list-style-type: none"> • Administer weekly for 4 weeks, with the initial dose as a split infusion in Week 1 on Day 1 and Day 2, then administer every 2 weeks thereafter until disease progression or unacceptable toxicity. • Administer premedications before each infusion as recommended. • The recommended dose of Rybrentav is based on baseline body weight: <ul style="list-style-type: none"> – Less than 80 kg: 1050 mg (3 vials) – Greater than or equal to 80 kg: 1400 mg (4 vials) <p><i>Note: Dose adjustments not required for subsequent body weight changes.</i></p>
