Approval of February, September and December Minutes. Winnie Andrews Moved to approve the three minutes, Angie Peters seconded. Motion passed.

Public Comment: This time is for EOCCO members or their representatives to ask questions to, provide feedback for, or express concerns about the EOCCO, GOBHI, MODA, or any other related entities.

- A member with an Autistic daughter had a successful and hopeful meeting with GOBHI, the LG School District and ECSE. They will be implementing a pilot program to collaborate in the school with ABA.
- The LG GOBHI office now has a space for ABA therapy to take place.

Incentive Measure Progress Report: Union County has reached a few more incentive goals in the last month and will continue to collect data, hopefully to improve our numbers even more. The hospital is currently doing hand counts to insure numbers are reported correctly.

CBIR Update 2018-19:

- Warming Station has had a successful year with many challenges and solutions. Final numbers next month.
- CHARM Is currently service 15 mom's and is changing lives
- Double up food bucks is working on the 2019 season opening
- Living Well has one more class going and will be finished in April.
- Trauma Informed Care is going to write a technical grant to continue building infrastructure and increase sustainability.
- Report will go out by the end of March!

CBIR Update 2019-20:

- Our grant was accepted in full of one contingency, there CBIR funds will only fund FTE for three years. There is some concern that our projects won't be as effective with out staffing. This unique experience to start new programs and help them start out successfully. The various entities and individuals don't have the capacity to do what our CBIR coordinator does for the projects. The LCAC would like to possibly push back and get clarification on why and the specifics of this contingency. The CBIR dollars for this year will be on hold until we accept the contingency.

Bridget Moved to write a letter stating that we see value in FTE to work on our projects and asking for reconsideration on the contingency. Angie Peters seconded. Motion Passed.

- The final report should reflect the value of the CBIR coordinator and the impact. The letter should include all of the outside funding sources and in-kind support that is working with the CBIR dollars. The letter should include the unbelievable professional growth and direction provided to the CBIR coordinator, an OHP member and a previously unemployed individual who has been empowered by this unique opportunity.
- All agencies interested in submitting letters should also do so, the LCAC letter will be worked on by Jen, Lisa, Cami and Amanda. All of the letters will be submitted with the final report. A draft letter will be sent out Tuesday and hopefully will come back to Cami as soon as possible, any letters not submitted by the 27th will not be able to be included.

Community Health Assessment Update: The subcommittee meeting was held this morning. The first meeting had some challenges with getting organized and started due to the overwhelmingly large amount of information. The committee will be meeting prior to the LCAC meeting over the next couple months. They have begun by going through topics and creating a summery, trying to sift out the priority areas.

- GRH has a draft of a needs assessment and they are requesting feedback and priority areas. They are hosting a community feedback event on April 2nd!
