- Daycare discussion about number of families that will receive daycare vs. how much of the budget we are spending on it. OHSU call clarifying information to be added.
- CASA Cribs OHSU call clarifying information to be added.
- Pain Clinic volunteer is already recruiting 15 members so far. Waiting list already even though funding isn't here yet!
- Enhancing Care Coordination discussion about project and patients having skin in the game.
- Community Wellness and Physical Activity Programs want data from 2018. Yoga needs to be opened up to multiple yoga providers in the community, licensure and insurance issues "eligibility checklist". Need to do more digging to find more yoga teachers. Will be a reimbursement rather than pre-pay.
- BUDGET Readjusted little highlighted changes, including Community Wellness \$5k gym, \$2k yak trax and walking poles, \$3k for yoga. "Kooyoos" rather than Yak Trax cheaper and easier.
  Childcare \$9,125 for tuition, \$1000 for equipment. CASA stays at \$1000. Care Coordination \$3500 gas, \$5200 housing assistance etc.
- Approx \$20k on incentive measure and \$17k to SDoH (60/70 and 30/40 split)
- Marilyn/Fiscal Agent maximum of grant is 6%. Want to cover her at a high rate if possible.
- NEXT STEPS Due Jan 31st. Jill, Autumn and Meg to finalize and then send around to LCAC.
